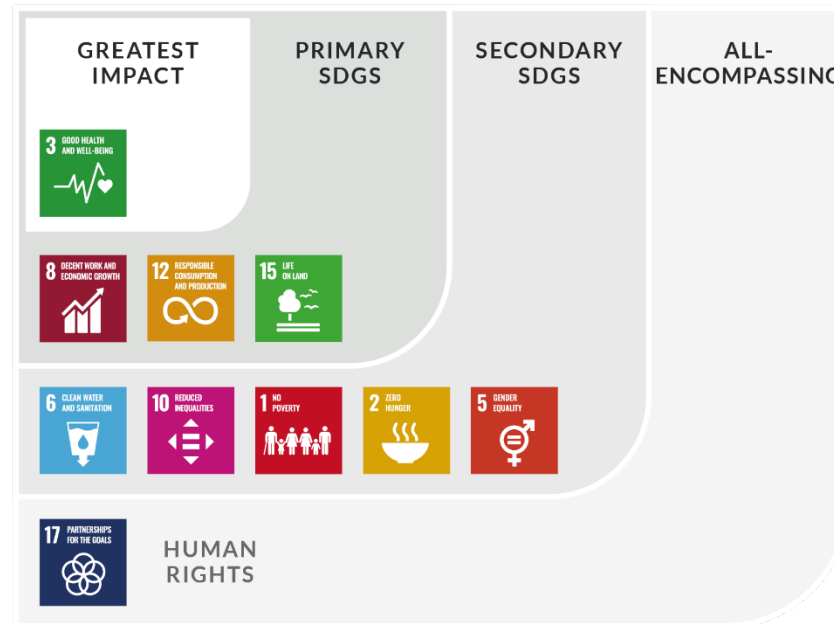




Sustainable Development Goals (SDGs) index

In this index, we have mapped our disclosures with the SDGs and their respective targets,¹ referencing where supporting information on our contribution can be found. We prepared this index based on the mapping conducted during our [2021 sustainability materiality assessment](#), and fine-tuned it in line with contents of our [Integrated Report 2021](#). Accounting for the SDGs into our reporting helps bring context to our own sustainability ambitions.
